Application Received for Response Period Extension

The Sahtu Land Use Planning Board ("SLUPB" or "Board") issued information requests to Selwyn Chihong Mining Ltd. ("the Proponent") on December 8 and 14 ("the IR's"). Responses from the Proponent were requested no later than 5:00 PM on December 22 and January 4, respectively. The Proponent applied on December 15, 2015 to extend the IR response period.
