**RE: NWLC response to letter from SLUPB, dated January 20, 2011**

Dear Sir / Madame:

This letter responds to a letter sent to the Norman Wells Land Corporation (NWLC) from the Sahtu Land Use Planning Board, dated January 20, 2011 and attached as Appendix "A".

On January 22<sup>nd</sup> and 26<sup>th</sup>, 2011 the NWLC held meetings with its Membership to address the questions raised in the January 20<sup>th</sup>, 2011 letter from the SLUPB. At the meetings, the Membership addressed each Map (1-16) in order and each question in order, as raised in the January 20<sup>th</sup> letter. The following important comment and chart summarizes the NWLC Membership's answers and recommendations to the questions raised:

## COMMENT

The fundamental recommendation being made by the NWLC is to have an adequate buffer zone around **all** key lakes and rivers in the Tulita District. Preferably, the buffer zone shall be zoned Conservation pursuant to the definition used in the Sahtu Land Use Plan. However, if Conservation zoning is impossible in certain locations, the NWLC would accept a Special Management Zoning in the buffer areas around the key lakes and rivers as a concession.

Also, in areas that have been traditionally used by the people of Tulita, the NWLC is prepared to support the zoning recommendations of the Tulita Elders', Tulita Land Corporation (TLC) and Fort Norman Metis Land Corporation (FNMLC), but maintains recommends strongly that all key lakes and rivers in the Tulita District be protected by applying an adequate buffer zone.



## **Re: Follow-up Questions from January 6-7, 2011 Consultation on Zoning of Settlement Lands**

Dear Mr. Norwegian,

At the follow-up consultation that the Sahtu Land Use Planning Board (SLUPB) held in Tulita on January 6-7, 2011 the Board committed to sending a list of questions regarding the TDLC's previous requested zone changes for settlement lands (comments submitted by Richard Hardy on October 21<sup>st</sup>, 2010), for which we require further clarification. We have attached a list of detailed questions to this letter. **We are asking for a written response on these questions by February 25<sup>th</sup>, 2011.**

We understand that Richard Hardy has arranged follow-up meetings with the District and the various organizations from both Tulita and Norman Wells between January 20<sup>th</sup> and 25<sup>th</sup> to seek resolution to these and other questions regarding zoning in the Mackenzie Mountains. Sixteen detailed maps were provided to participants at the January 6-7<sup>th</sup> meeting to assist with discussions on settlement lands as well as larger wall maps showing the proposed changes. The attached questions reference these 16 maps and break the questions down for each parcel. Each detailed map has an inset map in the upper corner to help you identify the area you are looking at. You can consult the larger wall maps to assist you as well. The third map in each set clearly identifies the parcels. Refer to the parcel number referenced in each question. Additional hard copies of the maps can be provided upon request.

To assist you in answering the detailed questions, please also give consideration to the following broad questions regarding your priorities for these lands.

- What are your goals for each parcel of settlement land?
- Why were those lands selected and how do you intend to use them in the future?
- In delineating Conservation Zones and Special Management Zones, the Board uses a 500 m buffer around lakes and a 1 km buffer around most rivers (except the Mackenzie, Great Bear and Mountain Rivers which currently have a 5 km buffer on each side). Where there is overlap between a parcel of settlement land and a buffer (for either a Conservation Zone or Special Management Zone), in general, is it more important to you to maintain the buffer for the river or lake, or to allow development in that portion of the parcel?



- In making decisions for each parcel, keep in mind your overall goals for the Mackenzie Mountains and valley as a whole. The most significant result of the proposed zone changes is the gradual erosion of the Mackenzie River, Carcajou River and Great Bear River Special Management Zones. Refer to the large wall map to see the cumulative effects of all the individual zone changes. Consider whether you intended to do this and what this means for the management of your lands. To this end, I've included a statement next to many of the proposed changes alerting you to broader planning considerations.
- Once you have decided what the new boundaries for Shuhtagot'ine Nene will look like, consider how you intend to manage settlement parcels that are located within or immediately adjacent to a National Wildlife Area. If a parcel falls within the new boundaries, do you intend to allow development there? If not, you may want to consider alternative designations – either Special Management or Conservation.

The Board will carefully consider your direction for the zoning of your settlement lands, and will be especially cautious to avoid blocking development opportunities for subsurface parcels. The Board also has a broader responsibility to ensure that the final zoning makes sense from a planning perspective, accurately reflects the values and goals for those areas, and is integrated with zoning for adjacent areas. Understanding the reasons for your direction for certain parcels will help us to meet those objectives when we make our final decisions on the Plan. As such, we encourage you to include a statement of rationale or explanation for requesting a given zone designation for your parcels in your response, especially where the direction may conflict with the zoning for surrounding areas.
